## ELEVATOR APPRENTICE - RESTRICTED REGISTRATION

**Credential Fee (nonrefundable): \$30.00** class code 8260

Make checks payable to: Department of Commerce. The fee consists of a \$15 application fee and a license fee of \$15. The credential will be effective for 4 years from the date of issuance.

\* **Notice** Information collected may be used for participation surveys, eligibility for approvals, law enforcement (including child support and tax delinquency enforcement) purposes and other secondary purposes. The Department may also provide this information to requesters pursuant to Wisconsin's open records law, ss. 19.31-19.39 stats. Social security numbers are required when applying for a license according to Wisconsin Stats. But they may not be disclosed to anyone except other State of Wisconsin governmental agencies.

**Reason for Credential:** A person who holds a credential issued by the department as a registered elevator apprentice-restricted may maintain or repair conveyances or replace conveyance components or subsystems, except the replacement of hoist ropes and governor ropes.

**Requirements of Credential:** A person who holds a registration issued by the department as a registered elevator apprentice-restricted may: under the general supervision of a person who is a licensed elevator mechanic or a licensed elevator mechanic-restricted, maintain and repair conveyances and replace conveyance components and subsystems, except the replacement of hoist ropes and governor ropes; or, under the general supervision of a person who is a licensed elevator mechanic, a licensed elevator mechanic-restricted, or a licensed lift mechanic, maintain and repair conveyances covered under ASME A18.1 and ASME A17.1 section 5.2.

A person who holds the credential shall carry on his or her person the credential issued by the department while performing or conducting the activity or activities permitted under the credential.

**Qualifications for Credential:** In accordance with Comm 5.995 (3), a person applying for an elevator apprentice-restricted registration to maintain or repair conveyances or replace conveyance components or subsystems, except the replacement of hoist ropes and governor ropes, shall be indentured in an elevator apprenticeship program recognized under ch. 106, Stats., or by the U.S. department of labor.
